

St Thomas' Rozelle Ordinance 1987 Amendment Ordinance 1997

No 44, 1997

Long Title

An Ordinance to vary the trusts on which certain money is held.

Preamble

- A. By clause 2(c) of the St Thomas Rozelle Ordinance 1987 (the "Principal Ordinance") the balance of certain proceeds of sale (the "Property") has been invested and the income applied in the manner set out in that ordinance.
- B. By clause 3 of the Principal Ordinance the churchwardens of St Thomas' Church, Rozelle were required, on or before 1 July 1997, to promote an ordinance providing for the distribution of the Property or the income arising from the Property, or both, having regard to the needs and commitments of the Provisional Parish of Rozelle and organisation within the Diocese of Sydney.
- C. By reason of circumstances which have arisen after the creation of the trusts on which the Property is held it is inexpedient to carry out and observe those trusts and it is expedient that further provision be made as provided herein.
- D. The Provisional Parish of Rozelle was amalgamated with the Assisted Provisional Parish of Lilyfield on 1 October 1996.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows -

Name of Ordinance

1. This Ordinance is the St Thomas' Rozelle Ordinance 1987 Amendment Ordinance 1997.

Declarations

- 2. By reason of circumstances which have arisen after the creation of the trusts on which the Property is held it is inexpedient to carry out and observe those trusts and -
- (a) it is inexpedient that the income of the Property be applied solely for the purposes of the provisional parish of Rozelle or wholly for the same or like purposes as the trusts on which the Property is held; and
- (b) it is expedient to amend those trusts on the terms set out in this Ordinance.

Amendments to Principal Ordinance

- 3. The Principal Ordinance is amended as follows -
- (a) clause 2(c)(ii) is deleted;
- (b) in clause 2(c)(iii) the matter "82.5" is deleted and the matter "87.5" is inserted instead;

- (c) in clauses 2(c)(iii) and 3 the matter "Provisional Parish of Rozelle" is deleted and the matter "Provisional Parish of Rozelle/Lilyfield" is inserted instead; and
- (d) in clause 3 the matter "1 July 1997" is deleted and the matter "31 December 2002" is inserted instead.
- 4. The provisions of clause 3 of this Ordinance shall operate with effect from 1 July 1997.
