"The Sydney Diocesan Revenues Ordinance, 1933."

No. 11, 1933,

AN ORDINANCE to provide for the payment out of Sydney Diocesan Revenues of certain expenses arising out of and incidental to the death of the Most Reverend John Charles Wright, late Archbishop of Sydney, Metropolitan of New South Wales, and Primate of Australia and Tasmania.

WHEREAS the Standing Committee of the Synod of the Diocese of Sydney, upon being informed of the death in New Zealand of the Most Reverend John Charles Wright, Archbishop of Sydney, Metropolitan of New South Wales, and Primate of Australia and Tasmania resolved to pay all the funeral expenses of the said John Charles Wright including the cost of the transport of the body from New Zealand to Sydney and for the purchase of a suitable area of ground in the Cemetery at South Head, Sydney AND WHEREAS the Standing Committee also resolved that a sum of Two hundred and fifty pounds should be paid to the widow of the said John Charles Wright to cover the cost of transport of the said widow and her daughter to England AND WHEREAS it may be expedient to purchase the furniture of the Dining Room and two bedrooms at Bishopscourt to be vested in the Church of England Property Trust Diocese of Sydney for the use of the present or any future Archbishop of Sydney at a sum not exceeding Seventy pounds AND WHEREAS it was necessary to arrange that the Right Reverend the Bishop Administrator of the Diocese should have episcopal assistance and the Standing Committee resolved that a sum of Fifty pounds should be provided for the expenses thereof AND WHEREAS there is now in the hands of the Church of England Property Trust Diocese of Sydney income accrued from the property mentioned in the Sydney Diocesan Revenues Act 1905 which is not required for any of the purposes mentioned in the said Act and is sufficient for the payment of the amount in this Ordinance mentioned and by reason of circumstances subsequent to the creation of the trusts to which the same is subject it has in the opinion of Synod become inexpedient to carry out or observe such trusts with regard to the amounts mentioned in this Ordinance Now THEREFORE the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the man"The Sydney Diocesan Revenues Ordinance, 1933."

agement and good government of the Church of England within the State of New South Wales and of all powers vested in the said Synod by the Church of England Trust Property Act of 1917 ordains, declares, directs and rules as follows:—

1. By reason of circumstances subsequent to the creation of the trust to which the said income is subject it has in the opinion of Synod become inexpedient to carry out or observe such trusts with regard to the amounts mentioned in this Ordinance.

2. The sum of Two hundred pounds paid for the purchase of land at South Head Cemetery for the grave of John Charles Wright is hereby validated.

3. The payment of the sum of Two hundred and nineteen pounds seven shillings and eightpence for the whole of the funeral expenses of the said John Charles Wright is hereby validated.

4. The payment of the sum of Two hundred and fifty pounds to the widow of the said John Charles Wright to cover the cost of transport of herself and her daughter to England is hereby validated.

5. The payment for the purchase if and when made of the furniture of the Dining Room and two Bedrooms at Bishopscourt belonging to the late Archbishop at a sum not exceeding Seventy pounds and to become part of the permanent furniture of Bishopscourt is hereby authorised.

6. The payment of the sum of Fifty pounds for the provision of episcopal assistance to the Bishop, Administrator of the Diocese, during his absence in Lord Howe Island, is hereby approved.

7. It is hereby ordered that the sum of Seven hundred and eighty-nine pounds seven shillings and eightpence being the total of the abovementioned payments shall be borne by the funds standing to the credit of the income referred to in the "Sydney » Diocesan Revenues Act 1005."

8. This Ordinance may be cited as the "Sydney Diocesan Revenues Ordinance 1933,"
