AN ORDINANCE to amend the West Kembla Mortgaging Ordinance, 1960.

WHEREAS by Ordinance No. 9, 1960, entitled West Kembla Mortgaging Ordinance 1960 Church of England Property Trust Diocese of Sydney (therein and hereinafter called the Corporate Trustee) was empowered to mortgage the land described in the Schedule thereto for the sum and purposes therein set out AND WHEREAS the Corporate Trustee is by virtue of Indenture of Conveyance dated 26th July 1916 Registered No. 567 Book 1088 made between Walter Evans of the one part and the Corporate Trustee of the other part seised of an estate in fee simple of the land described in the Schedule hereto upon trust for a Church, Parsonage or Parish Hall or partly for one and partly for another of such purposes in connection with the Church of England at Figtree AND WHEREAS it is expedient that the land described in the Schedule hereto be substituted for the land described in the Schedule to the said Ordinance No. 9, 1960 NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS AND DIRECTS as follows:—

1. Ordinance No. 9, 1960, entitled "West Kembla Mortgaging Ordinance 1960" is hereby amended by omitting therefrom the description contained in the Schedule thereof and by substituting therefor the description contained in the Schedule to this Ordinance.

2. This Ordinance may be cited as "West Kembla Mortgaging Ordinance (Amendment) Ordinance 1960."

SCHEDULE.

All that piece or parcel of land containing by admeasurement one rood more or less being a portion of Edward Gibson's one hundred and one acres situated near Figtree in the Parish of Wollongong County of Camden and State of New South Wales Commencing at a point on the western building line of the Main South Coast Road North one degree one minute East and eighty five links from the south east corner of Edward Gibson's one hundred and one acres which point is the north east corner of the

land purchased by the Trustees of the Church of England from the said Edward Gibson and bounded on the south partly by the north boundary of the Church of England property and partly by land of Robert Allen Gibson being a line bearing west one degree thirty minutes south one hundred and ninety nine links on the west by a line bearing north one degree thirty minutes west one hundred and twenty five links on the north by a line bearing east one degree thirty minutes north two hundred and one and five tenth links to the west building line of the Main South Coast Road and on the East by that building line bearing south ten minutes east one hundred and twenty five links to the point of commencement.
