
"Bishops Coadjutor ex Officio Ordinance 1940."

No. 14, 1940.

AN ORDINANCE to further amend the "Standing Committee Ordinance of 1897" to further amend the "Cathedral Ordinance 1935" to further amend "The Home Mission Society Ordinance of 1911" and to further amend the "Archbishop Enabling Ordinance 1910."

The Synod of the Diocese of Sydney ordains and rules as follows:—

1. (a) That the words "Bishop Coadjutor" inserted in Sub-Clause (2) of Clause (1) of the "Standing Committee Ordinance of 1897" by the "Standing Committee Ordinance of 1897 Further Amending Ordinance 1932" be deleted and the words "Bishops Coadjutor" be inserted in lieu thereof.
- (b) That there shall be inserted in Sub-Clause (2) of Clause (1) of the said "Standing Committee Ordinance of 1897" after the words "The Dean" the words "The Chancellor of the Diocese" and "The Registrar of the Diocese."

2. That the "Cathedral Ordinance 1935" be amended by omitting in Clause 10 the following words "The Bishop Coadjutor of Sydney shall by virtue of his office and while holding the same be a member of the Chapter with the duties rights and privileges of a Canon of the said Chapter and shall under this Ordinance take precedence next after the Dean of Sydney" and inserting in lieu thereof the following words: "The Bishops Coadjutor of Sydney shall by virtue of their offices and while holding the same be members of the Chapter with the duties rights and privileges of Canons of the said Chapter and shall under this Ordinance take precedence next after the Dean of Sydney and as between themselves according to the dates of their respective appointments as Bishop Coadjutor."

3. That "The Home Mission Society Ordinance of 1911" be amended by inserting in Clause 6 thereof immediately after paragraph (a) the following words:—

- (aa) The Bishops Coadjutor of the Diocese of Sydney who shall be Vice-Presidents (ex officio).

4. That the "Archbishop Enabling Ordinance 1910" as amended by the "Archbishop Enabling Ordinance 1910 Amendment Ordinance 1934" be further amended by omitting the proviso to Clause (1) thereof and inserting in lieu thereof "Provided that a Bishop Coadjutor may at the request of the Archbishop act as his deputy for the purposes of this Ordinance in respect of those bodies of which such Bishop Coadjutor is not ex officio or by election a member."

5. This Ordinance may be cited as "Bishops Coadjutor ex Officio Ordinance 1940."
