
*The Home Mission Society (Marriott Street and Ogden Lane
Splay) Ordinance of 1957.*

No. 11, 1957.

WHEREAS Church of England Property Trust Diocese of Sydney (hereinafter called "the Corporate Trustee") is the Registered Proprietor of All That parcel of land comprised in Certificate of Title Volume 5901 Folio 179 having a frontage to Marriott Street Redfern with a depth along Ogden Lane AND WHEREAS the said land is held by the Corporate Trustee upon the trusts and for the benefits purposes or use of The Home Mission Society (otherwise known as the Church Society of the Diocese of Sydney) and subject to the proviso declared and contained in Ordinance No. 6 of 1948 AND WHEREAS the said land is part of the land mortgaged to the Commercial Banking Company of Sydney Limited to secure certain advances to The Home Mission Society AND WHEREAS the Council of the City of Sydney for the purpose of splaying the corner of Marriott Street and Ogden Lane has requested the Corporate Trustee to transfer to it that portion of the said land described in the Schedule hereto in consideration of the payment of the sum of Ten pounds (£10) and in further consideration of the said Council restoring the fencing and services to the new boundary and paying the reasonable legal costs of the Corporate Trustee in connection with the transfer AND WHEREAS by reason of the said request it has become impossible or inexpedient to carry out or observe the said trusts and it is expedient to sell the said land Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and directs as follows:—

1. By reason of circumstances subsequent to the creation of the trusts upon which the said land is held it is expedient to sell to the Council of the City of Sydney upon the terms hereinbefore recited the land described in the Schedule hereto.

2. The proceeds of such sale shall be paid by the Corporate Trustee to The Home Mission Society whose receipt shall be a sufficient discharge therefor and which shall apply such moneys in terms of The Home Mission Society Ordinance of 1911.

3. This Ordinance may be styled and cited "The Home Mission Society (Marriott Street and Ogden Lane Splay) Ordinance of 1957."

THE SCHEDULE.

All that piece or parcel of land situated in Redfern at the corner of Marriott Street and Ogden Lane being a triangular parcel with a frontage of 8 feet to Marriott Street and a frontage of 8 feet to Ogden Lane and having an area of approximately 32 square feet being part of the land comprised in Certificate of Title Registered Volume 5901 Folio 179.
