The New Housing Church Building Fund Ordinance 1947 Amendment Ordinance 1948.

No. 15, 1948.

AN ORDINANCE to amend the New Housing Areas Church Building Fund Ordinance 1947 (No. 15, 1947) and for purposes incidental thereto.

WHEREAS the New Housing Church Building Fund Ordinance 1947 provides, inter alia, for Churches and/or other buildings in new housing areas in the Diocese of Sydney and for purposes incidental thereto.

WHEREAS a New Housing Area (said to be of a temporary nature) is being developed in the Warragamba Dam Scheme on land not owned by the Church and to which the provisions of the said Ordinance do not at present apply.

WHEREAS it is expedient that provision should be made for the application of portion of the moneys raised under and in pursuance of the provisions of the said Ordinance and should be applied in and towards the erection of a Church or other buildings on land within the area comprised within the Warragamba Dam Scheme.

AND WHEREAS it is expedient that the said New Housing Church Building Fund Ordinance 1947 be amended in certain particulars.

Now the Synod of the Diocese of Sydney ordains, directs and rules as follows:—

- 1. This Ordinance may be cited as "The New Housing Church Building Fund Ordinance 1947 Amendment Ordinance 1948."
- The New Housing Church Building Fund Ordinance 1947 is in this Ordinance refered to as the Principal Ordinance.
- 3. The Principal Ordinance as amended by this Ordinance may be cited as "The New Housing Church Building Fund Ordinance 1947/1948."
- 4. By reason of the circumstances subsequent to the creation of the trusts of the Church Trust Property referred to in the Principal Ordinance it has become inexpedient to carry out or

observe such trusts to the extent to which the same are varied by this Ordinance and it is expedient that such trusts be varied accordingly.

- 5. The Principal Ordinance is amended:-
- (a) By inserting at the end of Clause 3 the following:— "For the purposes of this Ordinance the Warragamba Dam Scheme shall be deemed to be a New Housing Area, and portion of the said moneys may be applied in erecting a Church and/or other building upon land in the said area although the Church does not own such land."
- (b) By adding the following proviso at the end of Clause 5:— "Provided that in the case of the Warragamba Dam Scheme a guarantee or other indemnity by the Council of The Home Mission Society of the Diocese of Sydney to repay the amount advanced, together with interest thereon, shall be deemed to be sufficient."
- 6. The provisions of the Sydney Church Ordinance 1912 as amended insofar as they are inconsistent with the provisions of this Ordinance are hereby suspended.
