Sydney Diocesan Retirements Ordinance Amendment Ordinance 1985 No 🎉 , 1985

AN ORDINANCE to amend the Sydney Diocesan Retirements Ordinance 1989-1979

Whereas it is expedient to make further provision for the retirement of clergymen. NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) This Ordinance may be cited as the "Sydney Diocesan Retirements Ordinance Amendment Ordinance 1985".

(2) The Sydney Diocesan Retirements Ordinance 1969-1979 (hereinafter called the "Principal Ordinance") as amended by this Ordinance may be cited as the "Sydney Diocesan Retirements Ordinance 1969-1985" and in any reprint of that Ordinance clause

18 shall be amended accordingly.

2. The Principal Grdinar following for clause 13:-The Principal Grdinance is amended by the substitution of the "13. (1) The Board (subject to the provisions of sub-clause (2) heroof) shall meet;—

upon the request, in accordance with clause 14 hereof, of the person requiring an extension of service; or upon the request in writing of the Archbishop or of an Assistant Bishop to consider whether it is appropriate that a parochial clergyman who has not made an application in accordance with the provisions of this Ordinance for an extension of retirement age should retire from the office to which he is 25 liconcod.

(2) Upon any such request being received by the chairman (or alternate chairman) he shall thereupon cause a meeting of the Board to be convened within three months from the date of such request being so received. (3) A request under sub-clause (1) (a) for an extension of service of 12 months or less by a person (other than a clergyman who has been granted an extension of service under this Ordinance) shall be dealt with by the Chairman (or alternate chairman) of the Board. (4) The chairman (or the alternate chairman shall notify a person whose request has been dealt with under sub-clause (3) of the

recommendation made to the Archbishop concerning the request. (5) A person who is dissatisfied with a recommendation made concerning his request may, within 14 days after receiving notifica-tion of the recommendation under sub-clause (4), require the re-quest to be dealt with by the Board and the Board shall deal with the request accordingly.
