AMENDMENT ORDINANCE 1977

No. 47 1977

AN ORDINANCE to amend the Sydney Diocesan Superannuation Fund Ordinance 1961-1974.

WHEREAS the Synod of the Diocese of Sydney by the Sydney Diocesan Superannuation Fund Ordinance 1961-1974 has established a Fund known as the Sydney Diocesan Superannuation Fund for the superannuation of clergy and certain other persons AND WHEREAS it is expedient to amend the provisions of that Ordinance NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-'

1. (1) The Sydney Diocesan Superannuation Fund Ordinance 1961-1974 is in this Ordinance referred to as the "Principal Ordinance".

- (2) This Ordinance may be cited as "Sydney Diocesan Superannuation Fund Amendment Ordinance 1977".
 - (3) The Principal Ordinance as amended by this Ordinance may be cited as "Sydney Diocesan Superannuation Fund Ordinance 1961-1977", and in any reprint of that Ordinance clause 1 (1) shall be amended accordingly.
 - 2. The Principal Ordinance is amended as follows:-

- (a) by omitting the words "in the Diocese of Sydney" from the preamble;
 - (b) by deleting clause 1(3) and inserting in lieu thereof the words and figures:-
 - "(3) The Ordinance is divided into Parts as follows:-
 - Part 1. Preliminary. clauses 1-2A.
- Part II. Board of Directors. clauses 3-11.
 - Part III. Powers and Duties of Fund and Board clauses 11A-17.
 - Part IV. Application of Fund. clause 18
 - Part V. Membership Contributions and Refunds. clauses 19-23A.
 - Part VI. General. clause 24"
- (c) by, in clause 2, inserting the definition of "Deaconess",
 together with the words following it prior to the definition
 of "Dependant" and inserting the definition of "Synod"

together with the words following it, prior to the definition of "Total and permanent disablement".

- 30 (d) by deleting from clause 11(b) the words "or ceasing from any other cause to be a member of Synod."
 - (e) by deleting from clause 18(a)(i) the word "and" where first occurring and the words "and sub-clauses".
 - (f) by deleting from clause 18(f) the word "sub-clause",
- 35 (g) by deleting from clause 22(1) the word "to" where sixthly appearing.
 - 3. The Principal Ordinance is further amended:-
 - (a) in clause 20(1) by deleting the words "and (2A)" and substituting the words "(2A), (2C) and (2D)" and by inserting the word "curate" after the word "rector"; by substituting the word "in" for the word "to" where first appearing in clause 20(1)(c);
 - (b) by deleting clause 20(1A);

- (c) by substituting the word "in" for the word "to" where first appearing in clause 20(2);
- (d) in clause 20(3) by deleting the word "deaconesses" and substituting the words "a curate or a deaconess" and by substituting the word "their" for the word "her" wherever appearing;
 - (e) by deleting clause 20(5).

4. The provisions of clause 3 of this Ordinance shall operate from the 1st day of January 1978.
