
*Sydney Diocesan Superannuation Fund Ordinance
Amendment Ordinance 1967*

No. 35, 1967.

AN ORDINANCE to amend the Sydney Diocesan Superannuation Fund Ordinance 1961-1965.

WHEREAS it is expedient to amend the Sydney Diocesan Superannuation Fund Ordinance 1961-1965 as hereinafter set out NOW the Synod of the Diocese of Sydney in pursuance of the powers in that behalf contained in the Constitutions for the Management and Good Government of the Church of England in Australia within the State of New South Wales and of all other powers vested in it hereby ordains and rules as follows:-

1. The Sydney Diocesan Superannuation Fund Ordinance 1961-1965 is in this Ordinance referred to as "the Principal Ordinance".

2. This Ordinance may be cited as "Sydney Diocesan Superannuation Fund Ordinance Amendment Ordinance 1967".

3. The Principal Ordinance as amended by this Ordinance may be cited as "Sydney Diocesan Superannuation Fund Ordinance 1961-1967".

4. Clause 19 of the Principal Ordinance is amended as follows:-
By inserting the following sub-clause as sub-clause (2A) thereof:-

"(2A) All clergymen under the age of 65 years next birthday who are on leave from the Diocese of Sydney with the approval of the Archbishop and who are serving in a full time capacity as Missionaries in the field (not in home base administration or activities) of any missionary society which may be approved by the Board may be admitted as members from time to time on such terms as the Board may determine.

5. Clause 20 of the Principal Ordinance is amended as follows:-

(i) By inserting at the end of sub-clause (1) (c) the words "or (subject to the provisions of clause 19 (2A) hereof) missionary society with which the member is associated".

(ii) By inserting in sub-clause (2) the words "or missionary society" after the word "Synod" and after the word "School" where lastly occurring.

(iii) by adding the following words as a proviso to sub-clause (3)

"Provided that in the event of no separate Incumbent being licensed or appointed as a successor in office during

a period of twelve months after such vacancy shall occur the Board may in its discretion waive as from the date on which the vacancy occurred any further proportion of contributions in whole or in part and for so long and for such period as it shall determine up to the time when such vacancy shall be filled.

Subject to any such waiver the Parish shall as from the date when the vacancy is filled pay for the then current year a proportionate part of its contribution for that year based on the number of days then still to run."

6. Clause 21 of the Principal Ordinance is amended by inserting after the words "Church of England Provident Fund (Sydney)" where firstly appearing the words "or at the discretion of the Board any other superannuation fund to which a member may be contributing" and by inserting after the said words where secondly appearing the words "or such other fund".
