## **Vesting of Land Ordinance 1999**

No 43, 1999

### **Long Title**

An Ordinance to consent to the vesting of certain land in Anglican Church Property Trust Diocese of Sydney.

#### Preamble

- A. The land described in part A of each of the Schedules is church trust property held on the trusts set out in part B
- B. The persons listed in part C of each of the Schedules are the registered proprietors of the land described in part A of the corresponding schedule.
- C. Under section 19 of the Anglican Church of Australia Trust Property Act 1917 it is expedient to consent to the vesting of the land in Anglican Church Property Trust Diocese of Sydney, the corporate trustee of the Diocese of Sydney.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows -

# Name of Ordinance

1. This Ordinance is the Vesting of Land Ordinance 1999.

### Consent

2. Under section 19 of the Anglican Church of Australia Trust Property Act 1917, consent is given to the land described in part A of each of the Schedules being vested in Anglican Church Property Trust Diocese of Sydney, the corporate trustee of the Diocese of Sydney.
